

# Privacy Notice

Welcome to [BMI Checker] (“App” or “Services”)! [Legendra] (“we”, “us”, or “our”) is committed to protecting your information and being transparent about the information we collect about you and how we use it. This General Data Privacy Notice (“Notice”) explains how we collect, share and use personal data about you, and how you can exercise your privacy rights.

## Section 1. The information we collect about you

We collect the following personal data about you:

- the type, version, brand, language and operating system of device.
- email address.
- behavioral usage of the App.
- the type and operator of network (such as Mac address).
- device identifiers (such as IDFA, IDFA for Android, GAID for IOS).

## Section 2. Why we collect your personal data

We process your personal data to:

- To help us understand how you are using our App. We do this so that we can better understand which parts of our App are more or less popular and to improve the structure and navigation of our App.
- To administer and protect our business and the App.
- To respond to user inquiries/offer support to users.
- We may use your information to request feedback and to contact you about your use of our App.
- We may use your information as part of our efforts to keep our App safe and secure (for example, for fraud monitoring and prevention).

## Section 3. When we share information

We share the categories of information described above with the following parties:

- We share data for advertising and related purposes.
- With vendors that we employ to process information on our behalf based on our instructions and for the purposes described in this Notice.
- With law enforcement agencies, government agencies, researchers, or other parties in compliance with laws, rules, or regulations. We only disclose information in response to such requests if we believe that disclosure is reasonably necessary to comply with a law, regulation or legal request; to protect the safety, rights, or property of the public, any person, or us.
- With our corporate family of companies, including wholly-owned subsidiaries and affiliates.

#### **Section 4. Privacy of children**

We do not knowingly collect personal data from children under 13. If you believe we might have any information from or about a child under the age of 13, please contact the us using the contact information above. If we learn we have collected or received personal data from a child under 13 without verification of parental consent, we will delete that information.

#### **Section 5. Retention**

We keep personal data for the length of any contractual relationship and, to the extent permitted by applicable laws, after the end of that relationship for as long as necessary to perform purposes set out in the Notice, to protect us from legal claims and administer our business. When we no longer need to use personal data, we will delete it from our systems and records or take steps to anonymize the data unless we need to keep it longer to comply with a legal or regulatory obligation.

#### **Section 6. Security**

We are committed to protecting the security of your personal data. We use appropriate technical and organizational measures to protect your personal

data from unauthorized access, use, or disclosure.

## **Section 7. Your rights and choices**

We offer you certain choices to control your data. Depending on where you live, these choices may also be privacy rights you have under local law:
